RELEASE AND WAIVER

I give this acknowledgement freely and knowingly. I represent and warrant that I am physically and mentally fit and that, as a result, able to participate. I do hereby assume responsibility for my own well-being.

I am fully aware that this is a potentially HAZARDOUS ACTIVITY, and possible physical injury might occur to me as a result of my participation. I agree to assume the full risk, including risk which is not specifically foreseeable of any injuries, including death, damages or loss, regardless of severity, which I may sustain as a result of participating in any and all activities connected with or associated with the WCB competition in which event shall include forging metals and shoeing live horses.
