## RELEASE AND WAIVER

In consideration of allowing me to participate in the World Championship Blacksmiths LLC ("WCB") horseshoeing and blacksmithing competition in **Big Horn, Wyoming**. I agree to the following and I am doing so on my own accord. I give this acknowledgement freely and knowingly. I represent and warrant that I am physically and mentally fit and that, as a result, able to participate. I do hereby assume responsibility for my own well-being.

I am fully aware that this is a potentially HAZARDOUS ACTIVITY, and possible physical injury might occur to me as a result of my participation. I agree to assume the full risk, including risk which is not specifically foreseeable of any injuries, including death, damages or loss, regardless of severity, which I may sustain as a result of participating in any and all activities connected with or associated with the WCB competition in which event shall include forging metals and shoeing live horses. Without limitation this release and waiver shall include acts or omissions and negligence, whether they be my own or those of anyone else.
